## How we get the personal information and what we use is for:

## When will we process your personal information:

In terms of the Protection of Personal Information Act (POPIA), the justification ground which we base our processing on consist out of the following:

- The processing is **necessary** to carry out actions for the conclusion or performance of a contract to which the data subject is a party;
- The processing complies with an **obligation** imposed by law on the business;
- The processing protects a **legitimate** interest of the data subject;
- The processing is necessary for the proper performance of a **public law** duty by the business;

Or

- The processing is necessary for pursuing the legitimate **interests** of the business or of a third party to whom the information is supplied.

## How we store your personal information:

Your information is securely stored:

- We keep your information for 4 years. We will then dispose your information by shredding/burning.

### **Your data protection rights:**

- You are entitled to access your personal data by sending a written request to the company. We may charge you a fee for this service.
- You may also request the company to correct or supplement any of your personal data which we will undertake as soon as practicable.
- Request the destruction of your personal data. The company will consider your request in light of any other laws or regulations prohibiting us from destroying your personal data.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
